Tender Information Document in respect of a tender offer for Samhällsbyggnadsbolaget i Norden AB (publ)'s outstanding SEK denominated perpetual capital securities

Samhällsbyggnadsbolaget i Norden AB (publ), Reg. No. 556981-7660 ("SBB" or the "Issuer") today announces its invitation to the holders of the SEK subordinated perpetual floating rate callable capital securities described below under "Purchase price" (the "Capital Securities") (including any beneficial owners who hold their Capital Securities via nominees or custodians) (the "Holders") to tender their Capital Securities for purchase by the Issuer for cash (the "Tender Offer"). The Issuer has appointed Nordea Bank Abp ("Nordea") as tender agent (the "Tender Agent") in connection with the Tender Offer.

The Tender Offer is made on the terms and subject to the conditions set out below.

Purchase price

Subject to terms and conditions set out in this tender information document and the applicable minimum denomination in respect of the Capital Securities, the Issuer offers to purchase all or any of the Capital Securities at the purchase price set out below (the "Purchase Price"):

The Issuer will also pay an amount equal to any accrued and unpaid interest on the Capital Securities on the Settlement Date (as defined below) in accordance with the terms and conditions of the Capital Securities ("Accrued Interest").

The Issuer has previously announced, on 16 October 2019, a tender offer of the Capital Securities and on 22 October 2019, the results of such tender offer (the "Previous Tender Offer"). As a result of the Previous Tender Offer and additional purchases of Capital Securities in the market by the Issuer, the Issuer has repurchased and currently holds more than 80% of the Issued Amount of the 2017 Capital Securities and the 2018 Capital Securities, respectively. The Issuer intends to exercise its right to redeem all outstanding Capital Securities upon a Substantial Repurchase Event (as defined in the terms and conditions of the 2017 Capital Securities and the 2018 Capital Securities, respectively), on or around 16 December 2019. **Please note that such redemption will be made at 100% of the principal amount of the Capital Securities which is significantly lower than the Purchase Price in the Tender Offer.**

Deadline

The Tender Offer expires at 12.00 CET on 4 November 2019, unless extended, re-opened, withdrawn or terminated at the sole discretion of the Issuer (the "Expiration Date"). The Issuer will announce the results and (acting in its sole and absolute discretion) whether any Capital Securities will be accepted under the Tender Offer as soon as reasonably practicable. Settlement of the Tender Offer is expected to occur at or around 6 November 2019 (the "Settlement Date"). Settlement of the transactions pursuant to the Tender Offer will occur as a secondary trade via the Tender Agent.

Subject to applicable law, the Issuer may, in its sole and absolute discretion, extend, re-open, amend or waive any condition of or terminate the Tender Offer at any time. Holders are advised to carefully read this document for the details of and information on the procedures for participating in the Tender Offer.

Purpose of the Tender Offer

The Tender Offer is being made to allow for remaining Holders to have their Capital Securities repurchased on terms similar to the Previous Tender Offer and as part of the Issuer's commitments to exercise active management of its balance sheet.

For the avoidance of doubt, the Issuer is not under any obligation to accept any tender of Capital Securities for purchase pursuant to the Tender Offer. Any tender of Capital Securities for purchase may be rejected by the Issuer for any reason, and the Issuer is not under any obligation to Holders to furnish any reason or justification for refusing to accept a tender of Capital Securities for purchase.

The Issuer's acceptance of Capital Securities validly tendered in accordance with the terms and conditions of the Tender Offer will be irrevocable.

Participation

Holders can only participate in the Tender Offer by submitting a valid tender instruction. Only Holders who are clients of, and can execute a secondary trade upon settlement with the Tender Agent with all required know your customer (KYC) and similar documentation in place to the satisfaction of the Tender Agent may participate in this Tender Offer and Holders must contact the Tender Agent to receive an application form that includes the details of how to participate in the Tender Offer. Tender instructions given via the application form are irrevocable by the Holders, except for in the limited circumstances described in the application form.

Holders should consult their own tax, accounting, financial and legal advisers regarding the suitability to themselves of the tax, accounting, financial, legal and regulatory consequences of participating in the Tender Offer.

Holders who do not participate in the Tender Offer, or whose Capital Securities are not accepted for purchase by the Issuer, will continue to hold their Capital Securities subject to the terms and conditions of the Capital Securities.
